basis of an identity certificate issued by a Gazetted Officer. In case of fresher's and candidates from private sector, a formal Police Verification Report will be obtained before their joining. Internal candidates are exempted.

3. The selection is provisional and subject to verification of eligibility documents/certificates. Candidates are required to produce original experience certificates at the time of joining including the current employment experience certificate without fail. All relevant documents including relieving letter in original and a photocopy set of the same are required to be produced at the time of joining.
4. The selection is on the basis of documents produced by the candidate. In case, it is detected at any stage of recruitment that he/she do not fulfill the eligibility norms and/or has furnished incorrect/ false information or has suppressed any material facts, his/her candidature will stand cancelled. If any shortcoming(s) is/are detected even after appointment, his services are liable to be terminated.
5. Selected Candidate has to undergo Medical examination on or before 16 Aug '24.
