- 1. #### 3. Bid Rejection criteria

- i. Bids of the Bidders who are debarred under PPP MII order 2017, GeM, CPPP including T ender holiday issued by MDL shall be rejected.
- ii. Bid Non-compliance/non-acceptance to any of the terms and conditions of the tender shall be liable for rejection.

### 5. INSPECTION:

The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover er storage charges & any consequential damages, from sale proceeds of such disposal.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period.
