Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

3. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

ADDITIONAL TERMS AND CONDITIONS (ATC)

- 1. This tender is a nominated Single tender and bidder who has received nomination & intim ation regarding tender from MDL is only eligible to submit the bid. All other bids if any rec eived will be summarily/categorically rejected.
- 2. **<u>Description & Scope of Supply:</u>** Procurement of Search and Rescue Transponder (SA RT) for Y-12653 & Y-12654 as per technical specification document of the tender.

3. PRE-QUALIFICATION CRITERIA:

- 3.1 Technical Pre-Qualification Criteria: Technical Pre-gualification is not required.
- 3.2 <u>Commercial Pre-Qualification Criteria</u>: Pre-qualification is not required.
- 4. **EARNEST MONEY DEPOSIT(EMD):** Not Applicable.
- 5. **PRICES:** Prices shall be quoted for line item of BoQ on all-inclusive basis as per terms and conditions of this tender as applicable for door delivery to MDL. Quoted prices shall remain firm & fixed during currency of contract.

6. Delivery schedule & consignee details:

- (a) Delivery date of shall be as indicated in GeM Tender.
- (b) Part Delivery: Part Supplies are acceptable.
- (c) The dispatch of goods and consignment are to be done at Planning-P17A, 4^h Floor, Service Block.
- (d) In order to avoid inconvenience during the delivery of material, it is advisable for suppli er to depute their representative in their own interest to coordinate the activities between the transporter, and MDL Y-12653/Y-12654.
- (e) Following document should be submitted along with material:
 - · PO copy & subsequent amendments issued to it, if any.
 - · Delivery Challans clearly indicating MDL Purchase Order No
 - Copy of Warranty Certificate
 - E-Way bill details are to be submitted during the delivery of the items
- (f) Unloading of the equipment/ items will be arranged by MDL. In case of delivery of Larg e/ Bulky/ Heavy consignments, supplier is required to give 2 to 4 day's advance intimation to MDL clearly indicating approx. dimensions and weight of consignments for arranging fo rk lift/crane for unloading.
- (g) Delay in submission of relevant documents as per tender requirement will delay CRAC process and delay the payment process, as payment timeline is 15 days from CRAC generation.
- 7. **PAYMENT MODE:** All the payments to indigenous bidders due shall be made through Rea I Time Gross Settlement (RTGS) / National Electronic Fund Transfer (NEFT) by MDL.

8. PAYMENT TERMS:

- 11. **GUARANTEE/WARRANTEE REQUIREMENT:** 12 Months from date of receipt at MDL.

12. **INSPECTION**:

Inspection shall be done by Berth Y-12653 & Y-12654 for respective schedules. Other g eneral conditions related to inspection of material are as under:

- 12.1 **Receipt Inspection:** MDL shall carry out necessary inspection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by MDL inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.
- 12.2 **Rejection of the material:** Any portion of the equipment found defective/rejecte d, the supplier shall collect the same at his cost from the MDL Yard, all incidental c harges being born by supplier, (inclusive of custom duty, if payable), within 30 day s from the date of intimation to the supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in a ny manner, to the best advantage to the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.

13. INDEMNIFICATION:

The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / Subcontractor, while on site of the Purchaser for the purpose of this contract, indemni fies the Purchaser against direct damage and/or injury to the property and/or the pers on of the Purchaser or that of Purchaser's employees, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / C ontractor, his employees, licensees, agents or Subcontractor by making good such damages to the property, or compensating personal injury and the total liability for such damages or injury shall be as mutually discussed and agreed to.

14. Right to Reject any or all Bids:

MDL reserves its right to accept or reject any or all Bids, abandon/ cancel the Tender process, and issue another tender for the same or similar Goods/Services at any time before the award of the contract. It would have no liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for such action(s).

15. PURCHASER'S PROPERTY:

All property (such as materials, drawings, documents etc.) issued by the Purchaser or any other individual or firm on behalf of the Purchaser in connection with the contract shall remain confidential, being the property of the Purchaser and the Bidd er/Supplier/Contractor shall undertake to return all such property so issued and will be responsible for any or all loss thereof and damage thereto resulting from whatev er causes and shall reimburse the Purchaser the full amount of loss and damage.

16. ISSUANCE OF E-INVOICE BY VENDOR:

- i. Vendors, whose aggregate turnover in any preceding financial year from 2017-18 onwards, exceeds Rs. 5 Crores as per GST Act, will have to issue an e-Invoic e with a QR code and invoice registration no (IRN). However, this rule will not ap ply to Micro enterprises with Udyam Registration No. (URN) as their turnover is I ess than Rs 5Cr.
- ii. Whenever GST is applicable, payment will be released against e-Invoice, or Invoice accompanied with vendor's self-declaration that "We do not fall under the category of registered persons notified under Rule 48(4) of the central GST Rule 2 017 and we are not required to comply with e-invoicing provisions under GST Act, as our aggregate turnover in any preceding financial year from 2017-18 onward has not exceeded Rs. 5 Cr as per GST Act".

17. OTHER TERMS & CONDITIONS:

Offer of the bidders who are debarred by MDL or issued tender holiday by MDL sha II be rejected.
