1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its

subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 8. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

9. Buyer Added Bid Specific ATC

A) Categorical Rejection criteria

a) Bidders who are debarred under PPP MII order 2017, GeM CPPP including tender holiday issued by MDL.

B) Liable for rejection criteria

Non-compliance/Non-acceptance to any of the terms and conditions of the tender.

C) Inspection: - (a) Receipt Inspection by MDL- MDL inspection cell & User dept. shall carry out necessar y inspection of the items on receipt in the MDL Yard. with the Inspection documents submitted by supplier s. Any objection raised by MDL inspection team against quality of material or workmanship shall be satisfa ctorily corrected by the supplier at his own expenses including replacement as may be required within sho rtest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.

(b) Rejection of the material: Any portion of the equipment found defective/rejected, the supplier shall coll ect the same at his cost from the MDL Yard, all incidental charges being born by supplier, (inclusive of cust om duty, if payable), within 30 days from the date of intimation to the supplier of such rejection. The MDL r eserves the rights to dispose off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL.& recover storage charges & any consequential damages, from sale procee ds of such disposal.

D. Warranty/Guaranty: System/Equipment/Material/Items/spares supplied shall be warranted for satisfa ctory performance for a minimum period of 12 months from the date of commissioning & acceptance. Duri ng this period, all defects arising out of defective material and faulty workmanship will be rectified by repai ring or replacing part or whole material as necessary, free of charge on door delivery basis. Any consequen tial damage/defect or loss of items due to poor workmanship/poor material quality/negligence etc. attribut e to the bidder to be rectified/replaced by the bidder free of cost. During the warranty period, all visits by t he firm technician, for breakdown / maintenance work will be on Non- Chargeable basis.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 11. Creating bid for items from irrelevant categories.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
