8. <u>Warranty:</u>

Warranty of one year to be given for the satisfactory performance of the equipment. During warranty any parts / items supplied by the party have to be repaired / replaced free of cost if found defective. During wa rranty period any breakdown call to be attended to within 24 hours of intimation over telephone / fax and t o be rectified within 24 hours. Any further delay in attending to / rectification of defect and breakdown be yond 24 hours is liable to extend the warranty period.

9. Delivery Period:

Supply of material should be within 4 weeks from the date of supply and installation and testing should be completed within 2 weeks. The entire order has to be executed (including SITC) within 6weeks from the date of placement of order.

10. Inspection:

i. <u>Pre-dispatch Inspection & Testing :</u>

Some of the tests mentioned in the scope shall be conducted at Manufacturer's Works by person nel using their own equipment's in the presence of MDL's representatives

ii. <u>Receipt Inspection</u>: MDL shall carry out necessary inspection of the items on receipt in the MDL yard, on the basis of an appropriate quality assurance system and inspection system requi rements, along with representative of the Supplier, any objection raised by MDL Inspection cell and user department against quality of materials or workmanship shall be satisfactorily correct ed by the Supplier, at his expense, including replacement as may be required within shortest p ossible time within 30 days. Items damaged during transit shall also be rectified/replaced by th e Supplier within shortest possible time. All additional cost towards replacement against defective items shall be borne by the supplier.

iii. <u>Rejection of Material</u>: Rejected materials, if any, shall have to be promptly lifted by the sup plier at his own expenses with his labour / transport as the case may be. Failure for lifting the re jected material within one week's time, from the date of intimation of the rejection, will be liable for disposal of the rejected material without notice and also for recovery of ground rent fo r storage of such material.

<u>Note</u>: Goods accepted by the purchaser at the initial and final inspections, in terms of the contrac t, shall in no way dilute the purchasers right to reject them later, if found defective in terms of t he warranty clause of the contract.
