- 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case o

(Preference to Make in India) Order, 2017.

bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. - (a) The Supplier cannot absolve their responsibility for warranty of material even though it is inspected y & approved by the inspection authorities.
- (b) If the defects are not remedied within a reasonable/stipulated time, MDL may proceed to rectify the efects at the supplier's risk & cost, but without prejudice to MDL's rights under the contract.
- (c) During the period of warranty / guarantee if any defect is noticed in the equipment / item supplied, t e supplier/ contractor will have to rectify such defects immediately at no extra cost to MDL. - Indemnification: The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / S bcontractor, while on site of the Purchaser for the purpose of this contract, indemnifies the Purchaser against irect damage and/or injury to the property and/or the person of the Purchaser or that of Purchaser's employee, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Su plier / Contractor, his employees, licensees, agents or Subcontractor by making good such damages to the pr perty, or compensating personal injury and the total liability for such damages or injury shall be as mutually a scussed and agreed to.
- **Purchaser's Property:** All property (such as materials, drawings, documents etc) issued by the Purchase or any other individual or firm on behalf of the Purchaser in connection with the contract shall remain confide tial, being the property of the Purchaser and the Bidder/Supplier/Contractor shall undertake to return all such roperty so issued and will be responsible for any or all loss thereof and damage thereto resulting from whatev r causes and shall reimburse the Purchaser the full amount of loss and damage.

13) Inspection:

- a) Receipt Inspection: MDL with Warship Overseeing Team (WOT) shall carry out necessary inspection of the iten s on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection doc ments submitted by suppliers. Any objection raised by MDL inspection team against quality of material or wo kmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be r quired within shortest possible time within 30 days. Items damaged during transit shall also be rectified or rej aced by the supplier within shortest possible time.
- b) Rejection of the material: Any portion of the equipment found defective/rejected, the supplier shall collect the ame at his cost from the MDL Yard, all incidental charges being born by supplier, (inclusive of custom duty, if ayable), within 30 days from the date of intimation to the supplier of such rejection. The MDL reserves the right sold to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage of the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.

c) <u>Issuance of e-Invoice by Vendor:</u>

- **a.** Vendors, whose aggregate turnover in any preceding financial year from 2017-18 onwards, excee s Rs. 5 Crores, as per GST Act, will have to issue an e-Invoice with a QR code and invoice registra on no (IRN). However, this rule will not apply to Micro with Udyam Registration No. (URN) as their urnover is less than Rs 5Cr.
- **b.** Whenever GST is applicable, payment will be released against e-Invoice, or Invoice accompanied ith vendor's self-declaration that" we do not fall under the category of registered persons notified nder Rule 48(4) of the central GST Rule 2017 and we are not required to comply with e-invoicing provisions under GST Act, as our aggregate turnover in any preceding financial year from 2017-18 nward has not exceeded Rs 5 Cr as per GST Act".

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the

bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
