- 1. PRICING: Price are firm and fixed till delivery of material to MDL Stores.
- 2. TECHNICAL REQUIREMENT: Procurement of Spares of Refrigeration Plant of Y-1 2653 of P17A as per part number/technical details provided in the tender. Spares parts will be procured from OEM of Refrigeration plants of MDL P17A ships through single tender in single bid. Hence, bids received from any bidder who has not received MDL email intimation regarding this tender (bidders other than OEM of Ref Plant of MDL P17A ships) will not be considered for bid evaluation and such bids shall be categorically rejected
- 3. **DELIVERY SCHEDULE**: Delivery Period: PO date + 02 Months.
- 4. <u>LIQUIDATED DAMAGES (LD)</u>: LD clause shall be applicable as per GEM condition @ 0.5% per week for delay in delivery of material subject to maximum 10% of the dela yed portion of the order.

- **5. INSPECTION:** Inspection agency shall be MDL User Department Other general cond itions related to inspection of material are as under:
 - a. The decision of the Inspecting Authority or their representatives, as the case may be, on any question of the intent, meaning and the scope of Specifications / Standards shall be final, conclusive and binding on the Bidder/ Supplier / Contractor.
 - b. Rejection of the material: Any portion of the equipment/item found defective/reject ed, the supplier shall collect the same at his cost from the site, all incidental charge s being born by supplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any mann er, to the best advantage to the MDL & recover storage charges & any consequenti al damages, from sale proceeds of such disposal.

6. Issuance of e-Invoice by Vendor:

- a. Vendors, whose aggregate turnover in any preceding financial year from 2017-18 o nwards, exceeds Rs. 10 Crores, as per GST Act, will have to issue an e-Invoice with a QR code and invoice registration no (IRN). While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
