1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

1. **PRICING:** - Price are firm and fixed till delivery of material to MDL Stores.

2. PRE-QUALIFICATION CRITERIA:

(a) Technical Pre-Qualification/Work Experience Criteria:

Manufacturer should have the proven and type tested design as per Annexure-3 of the TSP for 80 NB storm valve NAB (Angular). Manufacturer to submit the type test certificates and binding drawings of 80 NB Storm Valve NAB (angular) along with the offer towards the proof of type tested design.

3. TECHNICAL REQUIREMENT SHEETS/DRAWINGS/DRAFT QAP:

(a) **EQUIPMENT/ITEM**: Procurement of Hull Valves for 04 ship of MDL P17A (Y-12651 to Y-12654) oject.

4. DELIVERY SCHEDULE:

- a) Delivery date shall be PO+12 weeks for Y-12651 & 12652 and Delivery date shall be PO+16 eeks for Y-12653 & 12654.
- b) Part Delivery: Against Part Supply Part Payment is applicable

5. LIQUIDATED DAMAGES (LD):

LD clause shall be applicable as per GEM condition @ 0.5% per week for delay in delivery of mala subject to maximum 10% of the delayed portion of the order. In addition to that following LD c se shall also be applicable.

6. GUARANTEE/WARRANTEE REQUIREMENT:

The equipment / item along with associated auxiliaries/components supplied shall be warranted uaranteed for satisfactory Performance for the period of 48 months from date of receipt in MDL c 2 months from date of commissioning of ship whichever is later. Please Refer TSP clause for detail.

- a) The Supplier cannot absolve their responsibility for warranty of material even though it is increased by & approved by the inspection authorities.
- b) If the defects are not remedied within a reasonable/stipulated time, MDL may proceed to rec the defects at the supplier's risk & cost, but without prejudice to MDL's rights under the cont
- c) During the period of warranty / guarantee if any defect is noticed in the equipment / item su ied, the supplier/ contractor will have to rectify such defects immediately at no extra cost to L. For such rectification/repair work, if the supplier needs to take the supplied item/equipmer ut of MDL (in full or part), the supplier shall submit a separate BG of equivalent amount of va of item being taken out, to cover the cost of item.

7. INSPECTION:

It shall be Technical Specification as indicated in the Attached specification as TSP No 3024A date 06.02.2024 (Cla use No 12). Other general conditions related to inspection of material are as unc

- a) The decision of the Inspecting Authority or their representatives, as the case may be, on an uestion of the intent, meaning and the scope of Specifications / Standards shall be final, cousive and binding on the Bidder/ Supplier / Contractor.
- b) The Bidder / Supplier / Contractor shall accord all facilities to Purchaser's Inspectors / Nomi ed Agency to carry out Inspection / Testing during course of manufacture / final testing.
- c) Bidder shall directly offer for inspection agency through a call letter under intimation to us a ensure readiness of the items offered for inspection on the scheduled date & time.
- d) Receipt Inspection: MDL with Warship Overseeing Team (WOT) shall carry out necessary inscition of the items on receipt in the MDL on the basis of appropriate MDL Inspection system uirements & the Inspection documents submitted by suppliers. Any objection raised by MDI spection team against quality of material or workmanship shall be satisfactorily corrected the supplier at his expenses including replacement as may be required within shortest possitime within 30 days. Items damaged during transit shall also be rectified or replaced by the pplier within shortest possible time.

e) Rejection of the material: Any portion of the equipment found defective/rejected, the suppl shall collect the same at his cost from the MDL Yard, all incidental charges being born by su ier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the plier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the e of a total period of 90 days in any manner, to the best advantage to the MDL & recover sto e charges & any consequential damages, from sale proceeds of such disposal.

8. INDEMNIFICATION:

The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / Subcontract, while on site of the Purchaser for the purpose of this contract, indemnifies the Purchaser against irect damage and/or injury to the property and/or the person of the Purchaser or that of Purchase employees, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the neglic ce of the Bidder / Supplier / Contractor, his employees, licensees, agents or Subcontractor by maggood such damages to the property, or compensating personal injury and the total liability for his damages or injury shall be as mutually discussed and agreed to.

9. PURCHASER'S PROPERTY:

All property (such as materials, drawings, documents etc) issued by the Purchaser or any other is vidual or firm on behalf of the Purchaser in connection with the contract shall remain confident a eing the property of the Purchaser and the Bidder/Supplier/Contractor shall undertake to return such property so issued and will be responsible for any or all loss thereof and damage thereto reting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage

10. ISSUANCE OF E-INVOICE BY VENDOR:

- i. Vendors, whose aggregate turnover in any preceding financial year from 2017-18 onwards, ceeds Rs. 10 Crores, as per GST Act, will have to issue an e-Invoice with a QR code and invoic egistration no (IRN).
