**4. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**5. Generic**

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

**6. Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

**7. Certificates**

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

**8. Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

**Item: Supply and commissioning of Bow Shackles nut and bolts Type of 17T, 25T & 55T**

**1) Pricing:** - Prices are firm and fixed till delivery of material to MDL Stores.

**2) Delivery schedule:** Delivery date of items shall be as indicated in GeM Tender.

- a) Loading and Unloading at yard will be under the scope of the supplier
- b) Part Supply and Part Payment shall be applicable.
- c) The Successful bidder(s) shall arrange to dispatch of goods by appropriate Rail / Road/Air / Sea mode as per the order to MDL stores on working days (Monday to Friday) between 8.00 hrs to 15.00 hrs (Lunch Time 11.30 to 12.00 hrs). In case truck / tempo reach our yard beyond above time the same may be retained over night at your risk & cost
- d) Manufacturers identification, WLL Tracibility code, Grade to be hard stamped on each shackle.
- e) Certificate of manufacture
- f) Certificate to be provided from approved government certifiers for testing of each shackle to 2 times WLL in form 11. The validity of the certificate should be at least 12 months.
- g) All items to be supplied along with test certificates to designated standard, material certificate, guarantee certificate, standard accessories, operating & maintenance manual prior to dispatch.

**3) Bid Rejection criteria-**

**(A) Following bids shall be categorically rejected:**

- (i) Bids received after tender closing date and time.
- (ii) Bids received other than through e-portal (in case of e-tender).
- (iii) Bidders who are debarred under PPP MII order 2017, GeM, CPPP including Tender holiday issued by MDL.

**(B) Following bids shall be liable for rejection:**

- (i) Non-compliance/non-acceptance to any of the terms and conditions of the tender
- (ii) Any deviation in delivery period shall also falls under liable for rejection.

**4) LIQUIDATED DAMAGES (LD):**

LD clause shall be applicable as per GEM condition @ 0.5% per week for delay in delivery of material, However, this LD shall not be applicable in case the ordered items are delivered as per scheduled delivery date.

**Note:** LD is applicable with maximum ceiling as per GeM terms and conditions.

**5) Guarantee/warranty Requirement:** Warranty/Guarantee shall be applicable to all items. Firm has to give as minimum 1 years from date of acceptance of product by MDL.

- (a) The Supplier cannot absolve their responsibility for warranty of material even though it is inspected by & approved by the inspection authorities.
- (b) If the defects are not remedied within a reasonable/stipulated time, MDL may proceed to rectify the defects at the supplier's risk & cost, but without prejudice to MDL's rights under the contract.
- (c) During the period of warranty / guarantee if any defect is noticed in the equipment / item supplied, the supplier/ contractor will have to rectify such defects immediately at no extra cost to

MDL. For such rectification/repair work, if the supplier needs to take the supplied item/equipment out of MDL (in full or part), the supplier shall submit a separate BG of equivalent amount of value of item being taken out, to cover the cost of item.

**6) INSPECTION:** It shall be as per Gem bid.

- (a) The decision of the Inspecting Authority or their representatives, as the case may be, on any question of the intent, meaning and the scope of Specifications / Standards shall be final, conclusive and binding on the Bidder/ Supplier / Contractor.
- (b) The Bidder / Supplier / Contractor shall accord all facilities to Purchaser's Inspectors / Nominated Agency to carry out Inspection / Testing during course of manufacture / final testing.
- (c) Bidder shall directly offer for inspection agency through a call letter under intimation to us and ensure readiness of the items offered for inspection on the scheduled date & time.
- (d) **Receipt Inspection:** MDL (Mbi) shall carry out necessary inspection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by MDL (Mbi) inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.
- (e) **Rejection of the material:** Any portion of the equipment found defective/rejected, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being borne by supplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.

**7) PAYMENT MODE:**

- (i) Payments are processed against the documents as per purchase order along with copy of Purchase order and Revision to purchase order if any.
- (iii) **Issuance of e-Invoice by Vendor :**  
The vendors, whose aggregate turnover in any preceding financial year from FY 2017-18 onwards, exceeds INR 5 crore as per GST Act or as applicable from time to time, will have to issue an e-Invoice with a Quick Response (QR) code and Invoice Registration No.(IRN), It is important to note that MDL will not be entitled for Input Tax Credit (ITC)/GST on a vendor Invoice which is not compliant with the above e-Invoice notification. Wherever GST is applicable, payment will be released against e-Invoice, or Invoice accompanied with vendor's self-declaration that "*we do not fall under the category of registered persons notified under Rule 48(4) of the Central GST Rules, 2017 and we are not required to comply with e-Invoicing provisions under GST Act, as our aggregate turnover in any preceding financial year from 2017- 18 onwards has not exceeded INR 5 crore as per GST Act*".

**9) CONSIGNEE:**
