5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in

this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### **ADDITIONAL TERMS AND CONDITIONS (ATC)**

#### 1. **Preamble:**

- (a) Mazagon Dock Shipbuilders Limited (Buyer), invites e-offers in two bid system i.e. Part-I (Techno Commercial Bid) and Part-II (Price Bid) from Indian bidders (Sellers) only on GeM portal for **LED Safe Lead Lamp with Accessories** for Y-12652 to Y-12654.
- (b) Tender line items are inseparable.

#### 2. **Description & Scope Of Work:**

- (a) **MAIN ITEM:** Supply of LED Safe Lead Lamp with Accessories for Yard-12652 to Yard-12654 as per TSP No.P17A/5199 & as per MDL Drawing No- MSLED10001M REV-0.

#### 3. **Pre-Qualification Criteria:**

##### a) **Technical Pre-Qualification Criteria:**

- i. Vendors who have supplied LED safe lead lamp with accessories to Indian naval ships earlier shall only be considered for this requirements. Vendors should submit valid purchase order details in their offers.
- ii. Data sheet for the offer LED safe lead lamp with accessories indicating all technical parameters/ characteristics shall be submitted with technical offer.

##### b) **Commercial Pre-Qualification Criteria:** Not required.

#### **Note:**

- a) Bidder shall submit all documents pertaining to above pre-qualification along with Part I bid. Offers of Bidders(sellers) not meeting Pre-qualification criteria may lead to rejection of bid.
- b) MSEs will be given relaxation for prior turnover and prior experience subject to meeting of quality and technical specifications.
- c) The bidders need to upload / submit supporting documentary evidence in support of the Pre-Qualification Criteria Viz. Work / Purchase Order, Work Completion Certificate/ Proof of payment with

th Tax Invoice / Store Receipt and Acceptance Report or any other evidence that confirms that the work is completed which is issued by the party for whom the work is done. The concerned HoD or TNC has a right to verify / cause verification of authenticity of the documents whenever felt necessary.

4. **Prices:** Prices shall be quoted for each line item of BoQ on all-inclusive basis as per terms and conditions of this tender as applicable for door delivery to MDL Stores. Quoted prices shall remain firm & fixed during currency of contract.

5. **Delivery schedule:**

- (a) Delivery dates shall be as indicated in the GeM Tender.
- (b) Part Delivery: Part Supplies are acceptable.

- (d) In order to avoid inconvenience during the delivery of material, it is advisable for supplier to depute their representative in their own interest to coordinate the activities between the transporter, and MDL stores.
- (e) Following document should be submitted along with material:

  - Delivery Challans clearly indicating MDL Purchase Order No
  - Packing List
  - Copy of Warranty Certificate
- (f) Unloading of the equipment/ items will be arranged by MDL. In case of delivery of Large/ Bulky/ Heavy consignments, supplier is required to give 2 to 4 day's advance intimation to MDL clearly indicating approx. dimensions and weight of consignments for arranging fork lift/crane for unloading.

6. **Issuance of e-Invoice by Vendor:**

- i. Vendors, whose aggregate turnover in any preceding financial year from 2017-18 onwards, exceeds Rs. 5 Crores as per GST Act, will have to issue an e-Invoice with a QR code and invoice registration no (IRN). However, this rule will not apply to Micro enterprises with Udyam Registration No. (URN) as their turnover is less than Rs 5Cr.
- ii. Whenever GST is applicable, payment will be released against e-Invoice, or Invoice accompanied with vendor's self-declaration that "We do not fall under the category of registered persons notified under Rule 48(4) of the central GST Rule 2017 and we are not required to comply with e-invoicing provisions under GST Act, as our aggregate turnover in any preceding financial year from 2017-18 onward has not exceeded Rs. 5 Cr as per GST Act".

7. **Liquidated Damages (LD):**

LD clause shall be applicable as per GeM terms & conditions @ 0.5% per week for delay in delivery of material, in addition to that following LD clause shall also be applicable.

Note: LD is applicable with maximum ceiling as per GeM terms and conditions.

8. **Performance Bank Guarantee (PBG):** Bidders shall ensure that the validity of performance security is there as per Guarantee/Warranty requirement as stipulated in GeM Tender. In case any delay in delivery, vendor shall extend the validity of performance security suitably.
9. **Guarantee/warranty Requirement:** The equipment / material supplied shall be guaranteed/warranted for a period of twelve (12) months from the date of receipt of material. All other terms and conditions for warranty/Guarantee will be as per GeM terms & conditions.

10. **INSPECTION:** Inspection by MDL & WOT (MB) as per TSP.

- (a) Receipt Inspection: MDL with Warship Overseeing Team (WOT) shall carry out necessary inspection of

he items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the inspection documents submitted by suppliers. Any objection raised by MDL inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.

- (b) **Rejection of the material:** Any portion of the equipment found defective/rejected, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being born by supplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.

#### 11. **Indemnification:**

The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / Subcontractor, while on site of the Purchaser for the purpose of this contract, indemnifies the Purchaser against direct damage and/or injury to the property and/or the person of the Purchaser or that of Purchaser's employees, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / Contractor, his employees, licensees, agents or Subcontractor by making good such damages to the property, or compensating personal injury and the total liability for such damages or injury shall be as mutually discussed and agreed to.

#### 12. **Right to Reject any or all Bids:**

MDL reserves its right to accept or reject any or all Bids, abandon/ cancel the Tender process, and issue another tender for the same or similar Goods/Services at any time before the award of the contract. It would have no liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for such action(s).

13. **Purchaser's Property:** All property (such as materials, drawings, documents etc) issued by the Purchaser or any other individual or firm on behalf of the Purchaser in connection with the contract shall remain confidential, being the property of the Purchaser and the Bidder/Supplier/Contractor shall undertake to return all such property so issued and will be responsible for any or all loss thereof and damage thereto resulting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage.

#### 14. **Other terms & conditions:**

Offer of the bidders who are debarred by MDL or issued tender holiday by MDL shall be rejected.
