OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. 2. **DESCRIPTION & SCOPE OF SERVICE:** Servicing of 14 Nos Life Rafts for 20 Persons Capacity for Yard 12651 & Yard 12652 of P17A as under:
 1. Service provider to collect the Life rafts from Naval Dockyard, Vizag & on completion of work should deliver back the life rafts to onboard ship. Service Provider has to submit FIM Bank Guarantee or Indemnity Bond for Free Issue Material (FIM) with Insurance Cover for equivalent value of Life Rafts.
 2. To & fro Transportation charges has to be borne by contractor.
