- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.

d. Copy of EFT Mandate duly certified by Bank.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1.A) BID REJECTION CRITERIA:

- a) Categorical Rejection Criteria: The following conditions / deviations are non-negotiable and therefore an y bid falling under these condition ns / deviations shall be summarily rejected. Bidders to not e that they s hall not be provided any opportunity to rectify these conditions / deviations post bid opening;
- i. The bids received other than GeM portal.
- ii. The offer of the firms who are blacklisted/Debarred under PPP MII order 2017, GeM, CPPP including Tend er holiday issued by MDL shall be rejected and shall not be considered.
- b) Liable for Rejection Criteria:
- i. Bidder's failure to submit sufficient or complete details for evaluation of the bids within the given period depending on the deficiencies noticed for evaluation of the bid.
- ii. Bids with technical requirements and or terms not acceptable to MDL. Vendor has to submit an undertaking that the offered items are exactly as per the specifications mentioned in the tender's individual line items/schedules.
- iii. Bids received without asked documents / Bids not meeting the specified parameters stipulated in the te nder enquiry.
- iv. Deviation in delivery period shall be liable for rejection.
- v. This tender is exclusively reserved for MSE manufacturers and in case, if any bids are received from any non-MSEs or MSE of Trader or Service category, their bid may be rejected.
- 1.A) Eligibility Criteria:

Only MSE manufacturers are allowed to participate in this tender for the relevant category of tendered ite ms. Bidders to submit their Valid Udyam MSE certificate in their bid.

2.) Delivery Period:

- i. Delivery period is inclusive of time required for any clarifications sought with respect to making deliverie s in MDL. Successful bidder shall not be granted any delivery extensions.
- ii. The Successful bidder/s shall supply the material on door delivery basis to MDL on working day s (Mond ay to Friday) between 800 hrs to 1500 hrs (Lunch Time 1130 to 1200 hrs). In case truck/tempo reaches ou r yard beyond above time the same may be retained over night at your risk & cost. Loading and Unloading at yard will be under the scope of the supplier.
- iii. SUPPLY ON MDL HOLIDAYS: Request for permission for delivery on Saturday / Sunday / holidays if required, should be submitted 3 working days prior to the date of holiday.

5. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

6. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
