# 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

## 3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

## 4. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

- 1) **Pricing:** Price are firm and fixed till delivery of material to MDL Stores.
- 2) Items are inseparable in nature.

### 3) Commercial Pre-Qualification Criteria:

The minimum average annual financial turnover of the bidder during the last three years ending on 3 1<sup>st</sup> March of the previous financial year, should be **INR 11,25,000/- Lakhs** (**Rupees Eleven Lakh twenty-five thousand only**) Documentary evidence in the form of certified Audited Balance Sheet s of relevant periods or a certificate from the Chartered Accountant/Cost Accountant indicating the t urnover details for the relevant period shall be uploaded with the bid. In case the date of constitutio n/ incorporation of the bidder is less than 3-year-old, the average turnover in respect of the complet ed financial years after the date of constitution shall be taken into account for this criteria.

- 4) <u>Technical Requirement</u>: Fuse locker in IRL(RBU) Magazine as per Technical specification & as per a ttached drawing. Technical PQ criteria is mentioned in technical specification.
- 5) <u>Earnest Money Deposit(EMD)</u>: EMD shall be submitted as per GEM Terms & condition . EMD exem ption is as per GEM conditions, bidders shall submit valid EMD/EMD Exemption Certificate at the tim e of bidding only. In case valid exemption certificate is not submitted along with original bid then bid will be rejected. In addition to that, EMD is exempted for following:

#### 7) Liquidated Damages (LD):

i) LD clause shall be applicable as per GEM condition @ 0.5% per week for delay in delivery of material, In addition to that following LD clause shall also be applicable.

ii) LD @ 0.25% per week delay or part there of subject to maximum of 1% of total order value will also be r ecovered in case of delay in submission of Binding data, Drawings & QAP to the concern authority for appr oval. However, this LD shall not be applicable in case the ordered items are delivered as per scheduled

delivery date.

iii)The initial submission of the Layout drawing, manufacturing drawing & QAP

shall be of acceptable quality in the opinion of the concerned approving

authority.

Note: LD is applicable with maximum ceiling as per GeM terms and conditions.

8) <u>Performance Security</u>: Bidders shall ensure that the validity of performance security is there as per Guarantee/Warranty requirement plus two months. In case any delay in delivery, vendor shall exte nd the validity of performance security suitably.

#### 9) <u>Guarantee/Warranty Requirement</u>: 12 months from date of receipt of material only.

All other terms and conditions for warranty/Guarantee as per GeM.

- **10)** <u>Inspection</u>: Inspection shall be done by TPI agency nominated by MDL at Supplier premises. Supplier t o submit TPI inspection report at the time of delivery of material at MDL. Other general conditions rela ted to inspection of material are as under:
  - (a) The decision of the Inspecting Authority or their representatives, as the case may be, on any que stion of the intent, meaning and the scope of Specifications / Standards shall be final, conclusiv e and binding on the Bidder/ Supplier / Contractor.
  - (b) The Bidder / Supplier / Contractor shall accord all facilities to Purchaser's Inspectors / Nominated Agency to carry out Inspection / Testing during course of manufacture / final testing.
  - (c) Bidder shall directly offer for inspection agency through a call letter under intimation to us and e nsure readiness of the items offered for inspection on the scheduled date & time.
  - (d) The TPI (Third Party Inspection) charges shall be directly paid by MDL to MDL nominated TPI age ncy to Indian Bidders. These charges shall not be included in the bidder's quote as MDL has sep arate contract with the nominated TPI agency.
  - (e) <u>Receipt Inspection:</u> MDL shall carry out necessary inspection of the items on receipt in the MD L on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by MDL inspection team against quality of materia I or workmanship shall be satisfactorily corrected by the supplier at his expenses including repl acement as may be required within shortest possible time within 30 days. Items damaged durin g transit shall also be rectified or replaced by the supplier within shortest possible time.
  - (f) <u>Rejection of the material</u>: Any portion of the equipment found defective/rejected, the supplie r shall collect the same at his cost from the MDL Yard, all incidental charges being born by supp lier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the sup plier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage ch

arges & any consequential damages, from sale proceeds of such disposal.

- 11) <u>Indemnification</u>: The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Sup plier / Subcontractor, while on site of the Purchaser for the purpose of this contract, indemnifies th e Purchaser against direct damage and/or injury to the property and/or the person of the Purchaser r or that of Purchaser's employees, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / Contractor, his employees, licensees, agents or Subcontractor by making good such damages to the property, or compensating personal injury and the total liability for such damages or injury shall be as mutually discussed and agreed to.
- 12) <u>Purchaser's Property</u>: All property (such as materials, drawings, documents etc) issued by the Purchaser or any other individual or firm on behalf of the Purchaser in connection with the contract shall remain confidential, being the property of the Purchaser and the Bidder/Supplier/Contractor s hall undertake to return all such property so issued and will be responsible for any or all loss there of and damage thereto resulting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage.

जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
