1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. 2. Technical Pre-Qualification/Work Experience Criteria:

- a. The bidder should have past experience of supply of synthetic rubber based adhesive to any engineering industries.
- b. The bidder shall be approved manufacturer or authorized dealer / distributor of the manufacturer as per NCD 1433 Issue 01.
- c. The bidder shall submit the following documents:

7. LIQUIDATED DAMAGES (LD): LD clause shall be applicable as per GEM condition @ 0.5% per week for delay in delivery of material subject to maximum 10% of the delayed portion of the order. In addition to that following LD clause shall also be applicable.

8. GUARANTEE/WARRANTEE REQUIREMENT: Guarantee/Warranty shall be 12 months from the acceptance of items. All other terms and conditions for warranty/Guarantee as per GeM.

9. Performance Security (PSBG): Bidders shall ensure that the validity of performance security is there as per delivery requirement plus two months. In case any delay in delivery, vendor shall extend the validity of performance security suitably. All other terms and conditions for warranty/Guarantee as per GeM.

10. INSPECTION: Receipt inspection shall be done by MDL & WOT. Any objection raised by MDL inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.

- a) **Receipt Inspection:** MDL and Warship Overseeing Team (WOT)/Ship staff shall carry out necessary inspection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by MDL inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.
- b) **Rejection of the material:** Any portion of the equipment found defective/rejected, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being borne by the supplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.

11. INDEMNIFICATION:

The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / Subcontractor, while on site of the Purchaser for the purpose of this contract, indemnifies the Purchaser against direct damage and/or injury to the property and/or the person of the Purchaser or that of Purchaser's employees, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / Contractor, his employees, licensees, agents or Subcontractor by making good such damages to the property, or compensating personal injury and the total liability for such damages or injury shall be as mutually discussed and agreed to.

12. PURCHASER'S PROPERTY:

All property (such as materials, drawings, documents etc) issued by the Purchaser or any other individual or firm on behalf of the Purchaser in connection with the contract shall remain confidential being the property of the Purchaser and the Bidder/Supplier/Contractor shall undertake to return such property so issued and will be responsible for any or all loss thereof and damage thereto resulting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage.

13. ISSUANCE OF E-INVOICE BY VENDOR:

i. Vendors, whose aggregate turnover in any preceding financial year from 2017-18 onwards, exceeds Rs. 10 Crores, as per GST Act, will have to issue an e-Invoice with a QR code and invoice registration no (IRN). However, this rule will not apply to Micro with Udyam Registration No. (UFI) as their turnover is less than Rs 5Cr.

ii. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action
