1) This tender is an Indian Navy nominated limited tender and bidders who have received nomination & intimation regarding tender from MDL are only eligible to submit the bid. All other bids if any received will be summarily/categorically rejected.

2) Pricing: - Price are firm and fixed till delivery of material to MDL Stores.

3) Technical requirement sheets:

- Liquidated Damages (LD): LD clause shall be applicable as perGeM terms and cond itions.
- 6) <u>Performance Security:</u> Bidders shall ensure that the validity of performance securit y is there as per Guarantee/Warranty requirement plus two months. In case any delay in delivery, vendor shall extend the validity of performance security suitably.
- 7) Guarantee/Warranty Requirement: The equipment/ item along with associated component s shall be warranted by the equipment supplier for the stipulated performance for a period of twelve (12) months from the date of supply of the equipment/ item.

During the said period, the equipment supplied shall be warranted against any malfunction, defects, material failure, and non-compliance to ordered specifications, sub-optimal performance, design deficiency, poor workmanship and quality. Any expense on account of equipment malfunction, repair or supply of spares against guarantee defects is to be borne by the equipment supplier. If any defective part to be taken back to OEM's factory (i.e. importing and re-exporting from Country of origin), for

service purpose the liability of the same shall be borne by the supplier.

- 8) <u>INSPECTION</u>: Receipt Inspection shall be done by MDL & WOT. Other general conditions related to inspection of material are as under:
 - (a) Receipt Inspection: MDL with Warship Overseeing Team (WOT) shall carry out n ecessary inspection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by s uppliers. Any objection raised by MDL inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses in cluding replacement as may be required within shortest possible time within 30 d ays. Items damaged during transit shall also be rectified or replaced by the suppli er within shortest possible time.
 - (b) Rejection of the material: Any portion of the equipment found defective/reject ed, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being born by supplier, (inclusive of custom duty, if payable), within 30 d ays from the date of intimation to the supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage charges & any c onsequential damages, from sale proceeds of such disposal.

9) Issuance of e-Invoice by Vendor:

- (a) Vendors, whose aggregate turnover in any preceding financial year from 2017-1 8 onwards, exceeds Rs. 10 Crores, as per GST Act, will have to issue an e-Invoice with a QR code and invoice registration no (IRN).
