### 4. BID REJECTION CRITERIA:

#### a. Categorical Rejection Criteria

The following conditions / deviations are non-negotiable and therefore any bid fal ling under these conditions/ deviations shall be summarily rejected. Bidders to n ote that they shall not to be provided any opportunity to rectify these conditions/ deviations post bid opening:

- i. Bids/Offers received other than GEM portal.
- ii. Bids received without EMD (other than those who are exempted from p ayment of EMD).
- iii. Bidders who are debarred under PPP MII order 2017, GeM, CPPP including Tender holiday issued by MDL.

#### **b.** Liable for Rejection Criteria

Non-compliance/non-acceptance to any of the terms and conditions of the tender shall render the bid liable for rejection; Equal time and opportunity for submission of deficient techno commercial documents and clarification shall be given to the bidders. Bidders are required to submit such documents/ clarifications within the duration / date stipulated by MDL failing which their bids will be rejected.

- c. "Bidders are requested to ensure that only relevant documents complete in all re spect as indicated in the tender should be attached with their offer. The first pag e of every uploaded set of scanned document shall be an index of its contents. In case the offers received against this tender are more than 20, no opportunity will be extended for submission of deficient documents after opening of bids. The evaluation of the offers will be carried out and bidders will be qualified based on the documents received along with their offer."
- **d.** MDL reserves the right to seek clarification / deficient documents from all the bid ders quoted against the tender, if number of the techno-commercially qualified bi ds are less than X + 5 where X is the number of order proposed to be placed.

# 5. **PRICING:**

- 5.1. Contract Price shall remain firm and fixed for during duration of contract.
- 5.2. Bidder shall quote the price in the tender enquiry which will be inclusive of all c osts such as all the expenses such as manpower, Consumables to be provided by Service Provider, High End Machinery & Equipment to be provided by Servic e Provider, transport, supervision etc. and as per statutory requirements (mini mum wages, PF, Insurance, etc.). However, the applicable taxes/duties & levies will be indicated separately in the rate sheet. Illustration of Rate sheet format is as per **Annexure B of MDL ASLA.**
- 5.3. If a firm quotes NIL charges/ consideration against the tender, the bid shall be t reated as unresponsive and will not be considered.
- 5.4. No increases in price shall be admissible/allowed on account of any statutory in crease in or fresh Imposition of GST, customs duty or on account of any other ta xes/ duty/ cess/ levy), leviable in respect of the goods and services specified in the said contract which takes place after the original delivery date.
- 5.5. But nevertheless, MDL shall be entitled to the benefit of any decrease in price o n account of reduction in or remission of GST, Customs duty or on account of an y other Tax or duty or on any other ground as stipulated in the price variation cl ause or foreign exchange rate variation which takes place after the expiry of the original delivery date.
- 5.6. Notwithstanding any stipulation in the contract for increase in price on any othe r ground including price variation clause or foreign exchange rate variation, no such increase which takes place after the original delivery date shall be admissible on such of the said goods as are delivered after the said date.

Therefore, such refere nce price should not be considered as guidance price and the bidders shall quote their price based on their costing and pricing policies.
