1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

ADDITIONAL TERMS AND CONDITIONS (ATC)

<u>Item: Procurement of Heat exchanger and Centrifugal pump for onboard trials of AC plant for</u> <u>Y-12652 & 12653 (MDL P17A ships) as per tender terms & technical specifications given in TS</u> <u>P.</u>

1) **Pricing:** - Price are firm and fixed till delivery of material to MDL Stores.

2) Pre-Qualification Criteria:

(a) Technical Pre-Qualification/Work Experience Criteria:

The offers of the firms who are complying below criteria shall only be qualified for this procurem ent:

- i) Bidder should have supplied shell & tube type or plate type heat exchanger with minimum capacity of 500 KW or higher. During last five years.
- ii) Bidder shall submit purchase order copies along with its proof of supply in support of their p ast experience.

3) Technical requirement sheets/drawings/QAP:

- (a) <u>Equipment/Item</u>: Supply of Heat exchanger for onboard trials of AC plant for Y-12652 & 12653 (MDL-P17A project) as per requirement mentioned in tender & technical specifications of TSP pr ovided in the tender.
- (b) <u>QAP</u>: QAP submission period post PO placement is 1 week and QAP approval period is 1 week fro m date of QAP submission. It is to be noted that, delivery period mentioned in tender (98 days) include QAP submission (1 week) & approval period (1 week).
- 4) <u>Earnest Money Deposit(EMD)</u>: EMD shall be submitted as per GEM Terms & condition . EMD exem ption shall be as per GEM conditions. Bidders shall submit valid EMD/EMD Exemption Certificate at t he time of bidding. In case valid exemption certificate is not submitted along with original bid, then b id will be rejected. In addition to that, EMD is exempted for following:
 - a) Bidders registered with MDL. To qualify for EMD exemption, firms should necessarily submit vali d copy of the Registration Certificate issued by MDL, for the tendered items for which the offer i s being submitted, in Part-I offer/bid. Firms in the process of obtaining MDL registration/ in the p rocess of renewal of MDL registration will not be considered for EMD exemption.
 - **b)** Green Channel Status vendors qualify for EMD exemption. Such firms shall submit valid copy of the Green channel certificate issued by MoD for the items for which the offer is being submitted in Part-I offer/bid. Firms in process of obtaining this certificate will not be considered for EMD ex emption.

5) Delivery schedule:

Delivery period shall be 98 days from the date of placement of PO. It is to be noted that, delivery per iod mentioned in tender (98 days) include QAP submission period of 1 week & approval period of 1 w eek.

Note: If there is any delay in approval of QAP/drawings and same is not attributable to v endor, then corresponding days of delay will be added in contractual delivery period wit hout levy of LD.

6) LIQUIDATED DAMAGES (LD):

LD for delay in delivery of material shall be applicable as per GeM terms and conditions.

In addition to this, LD @ 0.25% per week delay or part there of subject to maximum of 1% of total order value will also be recovered in case of delay in submission of Binding data, Drawings & QA P.

Note: The initial submission of the Layout drawing/manufacturing drawing/QAP shall be of acceptabl e quality in the opinion of the concerned approving authority.

7) <u>Performance Security</u>: Bidders shall ensure that the validity of performance security is there as pe r Guarantee/Warranty requirement plus two months. In case any delay in delivery, vendor shall exte nd the validity of performance security suitably.

8) Guarantee/Warranty Requirement:

Guarantee/Warrantee shall be 12 months from date of delivery of material to MDL. All other terms an d conditions regarding warranty/Guarantee shall be as per requirement mentioned in tender & technic al specifications.

- **9) INSPECTION**: It shall be as per technical specifications mentioned in TSP. Inspection agency shall be MDL appointed TPI agency. Other general conditions related to inspection of material are as under:
 - (a) The decision of the Inspecting Authority or their representatives, as the case may be, on any question of the intent, meaning and the scope of Specifications / Standards shall be final, co nclusive and binding on the Bidder/ Supplier / Contractor.
 - (b) The Bidder / Supplier / Contractor shall accord all facilities to Purchaser's Inspectors / Nomina ted Agency to carry out Inspection / Testing during course of manufacture / final testing.
 - (c) Bidder shall directly offer for inspection agency through a call letter under intimation to us an d ensure readiness of the items offered for inspection on the scheduled date & time.
 - (d) The TPI (Third Party Inspection) charges shall be directly paid by MDL to MDL nominated TPI agency to Indian Bidders. These charges shall not be included in the bidder's quote as MDL has separate contract with the nominated TPI agency.
 - (e) <u>Receipt Inspection</u>: MDL with Warship Overseeing Team (WOT) shall carry out necessary insp ection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by M DL inspection team against quality of material or workmanship shall be satisfactorily correct ed by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replace d by the supplier within shortest possible time.
 - (f) <u>Rejection of the material</u>: Any portion of the equipment found defective/rejected, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being born by su pplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to th e supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at t he end of a total period of 90 days in any manner, to the best advantage to the MDL & recov er storage charges & any consequential damages, from sale proceeds of such disposal.
- **10)** <u>Indemnification</u>: The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / Subcontractor, while on site of the Purchaser for the purpose of this contract, indemnifies the Purchaser against direct damage and/or injury to the property and/or the person of the Purchaser or th

at of Purchaser's employees, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / Contractor, his employees, licensees, agents or Subcontr actor by making good such damages to the property, or compensating personal injury and the total I iability for such damages or injury shall be as mutually discussed and agreed to.

11) <u>Purchaser's Property</u>: All property (such as materials, drawings, documents etc) issued by the Pu rchaser or any other individual or firm on behalf of the Purchaser in connection with the contract sha II remain confidential, being the property of the Purchaser and the Bidder/Supplier/Contractor shall u ndertake to return all such property so issued and will be responsible for any or all loss thereof and d amage thereto resulting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage.

12) Issuance of e-Invoice by Vendor:

- Vendors, whose aggregate turnover in any preceding financial year from 2017-18 onwards, exc eeds Rs. 10 Crores, as per GST Act, will have to issue an e-Invoice with a QR code and invoice registration no (IRN). However, this rule will not apply to Micro with Udyam Registration No. (U RN) as their turnover is less than Rs 5Cr.
- **b.** Whenever GST is applicable, payment will be released against e-Invoice, or Invoice accompani ed with vendor's self-declaration that" we do not fall under the category of registered persons notified under Rule 48(4) of the central GST Rule 2017 and we are not required to comply with e-invoicing provisions under GST Act, as our aggregate turnover in any preceding financial yea r from 2017-18 onward has not exceeded Rs10 Cr as per GST Act".

13) Other terms & conditions

- i) Offer of the bidders who are debarred by MDL or issued tender holiday by MDL shall be reject ed.
