Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. **1. DESCRIPTION & SCOPE OF SUPPLY:** Supply of Aluminium Perforated Sheet for Y-12652, Y-12653 & Y-12654 as per attached drawing No 1602-01 Rev 3, BOQ and Specification.

**2. PRICING:** - Prices of all items/services listed in the price sheet format of the tender enquiry for delivery of the items at MDL Anik Store.

**3. Earnest Money Deposit(EMD):**

EMD shall be submitted as per GEM Terms & condition. EMD exemption is as per GEM conditions. In addition to that, EMD is exempted for following:

Bidders registered with MDL. To qualify for EMD exemption, firms should necessarily submit valid copy of the Registration Certificate issued by MDL, for the tendered items for which the offer is being submitted, in Part-I offer/bid. Firms in the process of obtaining MDL registration/ in the process of renewal of MDL registration will not be considered for EMD exemption.

Green Channel Status vendors qualify for EMD exemption. **6. GUARANTEE/WARRANTEE REQUIREMENT:** Guarantee/Warranty shall be 12 months from the acceptance of items. All other terms and conditions for warranty/Guarantee as per GeM.

**7. Inspection:**

- (a) **Receipt Inspection:** MDL and Warship Overseeing Team (WOT)/Ship staff shall carry out necessary inspection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by MDL inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.
- (b) **Rejection of the material:** Any portion of the equipment found defective/rejected, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being born by supplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.

**8. INTEGRITY PACT (IP):**

The Integrity pact essentially envisages the agreement between prospective vendors / bidders & buyers committing the person/officials of both the parties not to exercise any corrupt influence on any aspects of the contract. Only those vendors/bidders who enter into such an integrity pact with the buyer would be competent to participate in the bid. Therefore, non-acceptance and non-submission of IP by the vendors/bidders shall be liable to rejection. The format (**Enclosure 1**) of integrity Pact is enclosed with tender documents. IP shall be submitted on plain paper. The 'Integrity pact' dully filled as per enclosed format to be submitted along with the offer. Bidders to ensure that every page of IP is ink signed with company seal/stamp. The original of the uploaded copy of IP shall forward to MDL.

**9. INDEPENDENT EXTERNAL MONITORS (IEM):**

#### **10. INDEMNIFICATION:**

The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / Subcontractor, who is engaged at the site of the Purchaser for the purpose of this contract, indemnifies the Purchaser against direct damage or injury to the property and/or the person of the Purchaser or that of Purchaser's employees, agents, Subcontractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / Contractor or his employees, licensees, agents or Subcontractor by making good such damages to the property, or compensating personal injury and the total liability for such damages or injury shall be as mutually discussed and agreed to.

#### **11. PURCHASER'S PROPERTY:**

All property (such as materials, drawings, documents etc) issued by the Purchaser or any other individual or firm on behalf of the Purchaser in connection with the contract shall remain confidential, being the property of the Purchaser and the Bidder/Supplier/Contractor shall undertake to return all such property so issued and shall be responsible for any or all loss thereof and damage thereto resulting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage.

#### **12. ISSUANCE OF E-INVOICE BY VENDOR:**

- i. Vendors, whose aggregate turnover in any preceding financial year from 2017-18 onwards, exceeds 10 Crores, as per GST Act, will have to issue an e-Invoice with a QR code and invoice registration number. However, this rule will not apply to Micro with Udyam Registration No. (URN) as their turnover is less than Rs 5Cr.
- ii. Whenever GST is applicable, payment will be released against e-Invoice, or Invoice accompanied by Vendor's self-declaration that "we do not fall under the category of registered persons notified under Section 8(4) of the central GST Rule 2017 and we are not required to comply with e-invoicing provisions under the GST Act, as our aggregate turnover in any preceding financial year from 2017-18 onward has not exceeded 10 Cr as per GST Act".

#### **13. OTHER TERMS & CONDITIONS:**

- i. Offer of the bidders who are debarred by MDL or issued tender holiday by MDL shall be rejected.
- ii. **Consignee:**
  - (a) Material scheduled for delivery are to be delivered at MDL stores.
