1. **DESCRIPTION & SCOPE OF WORK:**

(a) **MAIN EQUIPMENT/ITEM/SYSTEM:** Design, Manufacture, Supply and Commissioning of Fixed Fire Fighting System along with all the accessories for Yard-16101 (01 CTS) as per SOTR no: 3048 ver 01 dated 05.03.2024.

(b) **ON BOARD SPARES (OBS):**

OBS for sufficient quantity for exploitation & on-board maintenance up to 2 years from date of completion of " Standard Warranty" (As mentioned in warranty cl no. 26 of respective SOTRs) is required to be provided along with the main equipment for Yard-16101 (01 CTS). Please refer respective SOTR s cl no. 13.3 for more details

- (i) OBS will be ordered along with the main equipment.
- (ii) It is mandatory to quote OBS for 2 year of exploitation period.

- (ii) B&D spares list along with Comprehensive Part Identification list (CPIL)/Manufacturers Recommended list of Spares (MRLS) for five-year exploitation and maintenance **to be submitted separately**.
