#### 2. Generic

(a) MAIN EQUIPMENT/ITEM/SYSTEM: Design, Manufacture, Supply and Commissioning of Fixed Fire Fighting System along with all the accessories for Yard-16101 (01 CTS) as per SOTR no: 3048 ver 01 dated 05.03.2024.
