- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchas preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview o Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. 2. **PRE-QUALIFICATION CRITERIA**:

Technical: The dealers/resellers submitting the bid must be in possession of valid certificate of dealership/au orization letter issued by OEM (M/s Sanchar Communication System)

Commercial: Not Applicable

3. **BID REJECTION CRITERIA**

a) Categorical Rejection Criteria: The following conditions / deviations are non-negotiable and therefor any bid falling under these conditions / deviations shall be summarily rejected. Bidders to note that they hall not be provided any opportunity to rectify these conditions / deviations post bid opening:

- (i) Bids received after tender closing date and time.
- (ii) Bids received other than through e-portal (in case of e-tender).
- (iii) Bidders who are debarred under PPP MII order 2017, GeM, CPPP including Tender holiday issued y MDL.

b) Liable for Rejection Criteria:

5. **PRICING:**

- (ii) The prices quoted shall remain firm and fixed during the currency of the order / contract unless agreed oth wise by MDL.

9. **INSPECTION**:

- (a) Receipt inspection by MDL & WOT.
- (b) The decision of the Inspecting Authority or their representatives, as the case may be, on any question of e intent, meaning and the scope of Specifications / Standards shall be final, conclusive and binding on the idder/ Supplier / Contractor.

10. Validity Period of Offer:

- (a) Bid / Offer shall have the validity period of **180 days** from the tender closing date.
- (b) In case the day up to which the bids are to remain valid falls on/ subsequently declared a holiday or closed day for MDL, the bid validity shall automatically be deemed to be extended upto the next working date.
- (c) In exceptional circumstances, before the expiry of the original time limit, MDL may request the bidders o extend the validity period for a specified additional period. The request and the bidders' responses she like made in writing or electronically. A bidder may agree to or reject the request. A bidder who has agreed to MDL's request for extension of bid validity, in no case, he shall be permitted to modify his bid.

 - · Breach of confidentiality obligations or infringement of intellectual property rights.
 - · Indemnity obligations for third-party claims.
 - · Non-compliance with applicable laws, regulations, or statutory obligations.
 - · Liquidated Damages expressly agreed upon by the parties. Breach of obligations of Integrity Pact (IP).
 - · Any other liability that cannot be limited or excluded under Applicable Law.
- (d) **Mutuality:** The liability cap shall apply mutually to both parties unless otherwise agreed in viting.
