In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

- DESCRIPTION OF WORK / SUPPLIES / SERVICES:** Biennial Rate Contract for Hiring Services of Loader Cum Excavator for various jobs at MDL yard and Anik Chembur yard along with Driver.
- SCOPE OF WORK:** The detailed technical scope of work is enclosed at [Annexure-A](#). Loader cum Excavator will be utilised for various types of jobs in MDL. Viz. Shifting of various types of scrap, debris, rubbish etc. from various locations in MDL to scrap bins, Loading of Rubbish-refuse, Debris, Soil etc. into the dumper, excavation, levelling of soil etc. whenever required.

Also, the contractor should provide services of Backhoe loader cum Excavator with Rock /Concrete Breaker for demolishing concrete structure or breaking of rock whenever required on shift basis. Excavator Rock breaker (percussion hammer fitted to a loader cum excavator) should be supplied as per the requirement.

Specification: Contractor should provide one no. LOADER Cum EXCAVATOR as & when required by User Dept (TS-YUC). Loader Cum Excavator should be of JCB make, Model #3DX or equivalent, must have attachment of CLAMP SHOVEL (Kaitychy Bucket). This is required for loading of Rubbish-Refuse-Garbage-Soil/Debris into the trucks/dumpers. This attachment is named "BACKHOE BUCKET & SHOVEL" in the JCB Brochure. The Loader cum Excavator should not be older than TWO years i.e. October 2023 Model onward.

"The bidder should have past experience in shifting of various types of scraps, debris, rubbish & demolishing concrete structures on breaking of rocks, using Loader cum excavator"

3.1.2. **At least one number loader cum Excavator (Owned/MoU) must be registered in the name of contractor or in the name of partners of the contractor.**

3.1.3. **Bidder's experience of having executed/completed similar services during last 7 years ending till the original tender closing date should be either of the following:**

3.2. **COMMERCIAL PQ CRITERIA**

3.2.1. The bidder should have a minimum average turnover of at least for **Rs. 5 Lacs** during the last three years ending 31st March 2024 (i.e. for FYs 2021-22, 2022-23 and 2023-24) as per the annual report (audited balance sheet and profit and loss account) of the relevant period, duly authenticated by a Chartered Accountant. 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
