1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

#### 3. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

- 2. <u>Pre-Qualification Criteria</u>: The offers of the firms who are complying below criteria shall only be qualified for this procurement:

### (a) Technical Pre-Qualification/Work Experience Criteria:

- (i) Vendors should have manufactured and supplied pneumatic valves of working press ure of 200 Bar or more to any Warship / Marine / Oil and Gas applications.
- (ii) Relevant Purchase Orders (PO) and WDC / CRAC / proof of supply, for proved the PQ criterion shall be submitted.

- (iii) Bidders, who might not have received orders but have proven design of required ite ms, type tested and inspected by recongnized/ reputed inspection authority/ accept ed by Indian Navythrough prototype trials on board.

- 8. <u>Guarantee/Warranty Requirement</u>: As per TSP No.: DR/E/P17A/3042B REV-0 date d 08/05/2024, HP Air Valves shall be warranted by the supplier for the stipulated perf ormance for a period of forty-eight (48) months from the date of delivery of fittings to MDL."

- **9. INSPECTION**: It shall be as perTSP. Inspection shall be done by IACS appointed by MDL agency nominated by MDL at Supplier premises. Supplier to submit IACS inspecti on report at the time of delivery of material at MDL. Other general conditions related t o inspection of material are as under:
  - (a) The decision of the Inspecting Authority or their representatives, as the case may be, on any question of the intent, meaning and the scope of Specifications / Stan dards shall be final, conclusive and binding on the Bidder/ Supplier / Contractor.
  - (b) The Bidder / Supplier / Contractor shall accord all facilities to Purchaser's Inspect ors / Nominated Agency to carry out Inspection / Testing during course of manufa

cture / final testing.

- (c) Bidder shall directly offer for inspection agency through a call letter under intimat ion to us and ensure readiness of the items offered for inspection on the schedule d date & time.
- (d) The IACS appointed by MDL charges shall be directly paid by MDL to MDL nomina ted TPI agency to Indian Bidders. These charges shall not be included in the bidd er's quote as MDL has separate contract with the nominated TPI agency.
- (e) **<u>Receipt Inspection</u>**: MDL with Warship Overseeing Team (WOT) shall carry out necessary inspection of the items on receipt in the MDL on the basis of appropriat e MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by MDL inspection team against quality of materia I or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.
- (f) <u>Rejection of the Material</u>: Any portion of the equipment found defective/reject ed, the supplier shall collect the same at his cost from the MDL Yard, all incidenta I charges being born by supplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the supplier of such rejection. The MDL reserv es the rights to dispose-off the rejected item at the end of a total period of 90 da ys in any manner, to the best advantage to the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.
- 10. Indemnification: The Bidder / Supplier / Contractor, his employees, licensees, age nts or Sub-Supplier / Subcontractor, while on site of the Purchaser for the purpose o f this contract, indemnifies the Purchaser against direct damage and/or injury to the property and/or the person of the Purchaser or that of Purchaser's employees, agent s, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / Contractor, his employees, licensees, agents or Subcontractor by making good such damages to the property, or compensating personal injury and the total liability for such damages or injury shall be as mutually discussed and agreed to.
- **11.** <u>Purchaser's Property</u>: All property (such as materials, drawings, documents etc) is sued by the Purchaser or any other individual or firm on behalf of the Purchaser in co nnection with the contract shall remain confidential, being the property of the Purcha ser and the Bidder/Supplier/Contractor shall undertake to return all such property so i ssued and will be responsible for any or all loss thereof and damage thereto resulting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage.
