- a) Sling should be Twin path having two separate independent paths for hold the load in the seamless tube with 100% backup protection.
- b) Sling should be of high performance Fiber as per standard ASME B 30.9
- c) Fiber Slings should not weaken with age.
- d) It should not damage the surface of the job which is to be handled; there should be no risk of damage to sensitive/machined surfaces.
- e) Suitable to absorb any type of shocks.
- f) Should be easier for physical inspection.
- g) Weight wise it should be light, easier to transport, quicker to handle and occupy less storage space.
- h) The slings should be supple/ flexible and accommodate irregularities of the load / object.
- i) Should be much lighter in weight to about 6% the weight of steel. It should have the property to stretch equivalent to steel and ideal for all applications where low elasticity is required.
- j) The HPF sling should have check fast system with external warning indicator. The

Check fast system is designed to improve job-site safety. The check fast tag and external warning indicator (EWI) on sling provides core yarn inspection facility for the following:

- (i) Damage to the core yarn from the ultraviolet (UV) light degradation,
- (ii) Damage to fiber on abrasion,
- (iii) Fatigue,
- (iv) Sever overload on the yarn.
- (v) If the sling is mistakenly overloaded beyond rated capacity, the EWI is designed to disappear (goes in) before the sling fails.
- k) Slings should have fiber optic device for inspection of the sling yarn inside the sling cover.
- Sling should have repairing facilities, it should have double tube construction, so that the outer sling cover can be patched if torn.
- m) It should be provided with color code for easy identification. As per EN standard (High visibility)
- n) Each CORE should have equal Safety Factor of 2.5: 1 & 2.5:1 = 5:1
- o) The sling in Tube-in-Tube will have the inner tube of polyester, outer tube of heavy duty abrasive resistant cover & the different colour of inner tube is for easy inspection if the outer tube is damaged.
- p) The sling should be manufactured out of high capacity textile slings of manmade fiber having very low elongation (less than 1 %) at WLL.
- q) The sling should have double cover. The outer cover should have high abrasive resistance.
- r) Inspection and certification: Pre Dispatch Inspection required.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as

null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
