1. Preamble

- 1.1 This Corrigendum is issued under Section 12.2 of the Enquiry, which reserves MDL's right to amend the Enquiry by corrigendum. It effects an extension of the key dates only. No qualifying criterion, evaluation criterion, term or Annexure of the Enquiry, as amended by Corrigendum No. 01, is otherwise amended.
- 1.2 Corrigendum No. 01 restructured the Joint Venture / Consortium provisions of the Enquiry, including the introduction of the Financial Member route at Clause 5.5.7(b) and the new Annexure H-1. Representations have been received that the time available to constitute a compliant Joint Venture / Consortium, execute the Agreement at Annexure H and the Corporate Guarantee at Annexure H-1, and complete banking formalities is insufficient. To afford all Bidders, including those newly eligible under Corrigendum No. 01, a reasonable opportunity to submit responsive offers, the closing date is extended as at Section 2 below.
