Selection of an Execution Partner on a Back-to-Back Basis for 120 x Fast Interceptor Craft – Indigenous (FIC-I) — Extension of Closing Date

against MoD RFP No. TM(M)/0025/DSP/120xPIC-I dated 16 June 2026 — Buy (Indian-IDDM)

1. Preamble

- 1.1 This Corrigendum is issued under Section 12.2 of the Enquiry. It effects an extension of the key dates only. No qualifying criterion, evaluation criterion, term or Annexure of the Enquiry, as amended by Corrigenda Nos. 01 and 02, is otherwise amended.
- 1.2 The Buyer has, by amendment / corrigendum dated 31st August 2026 to the RFP, revised the bid submission date under the RFP to 04th September 2026. Consequent upon that revision, and to afford Bidders adequate time to complete Joint Venture / Consortium formalities, banking arrangements and the technical submissions required with the Stage-1 offer, the closing date of this Enquiry is extended as at Section 2 below.
- 1.3 Clause 3.3 of Corrigendum No. 02 (no further extension) was expressed with reference to the bid submission date under the RFP as it then stood, and is superseded to the extent of the dates at Section 2. All other provisions of the earlier corrigendum(s) continue to apply.

Note: Offers shall be submitted in the dual mode prescribed at Section 8 (physical sealed cover and password-protected e-mail); the split-password protocol for the Price Bid applies unchanged. Offers shall remain valid for the validity period at Section 8 reckoned from the extended closing date.

3. General

- 3.1 Offers already received by MDL against any earlier closing date remain valid and will be taken on record. A Bidder that has already submitted may, at its option and without prejudice, withdraw and re-submit a revised offer, or submit supplementary documents in a sealed cover clearly superscribed as such, at any time before the extended closing date at SI A-2. Where both an original and a revised offer are on record at closing, the revised offer alone will be opened. Earnest Money Deposit instruments already furnished continue to hold good and need not be re-submitted, provided their validity covers the offer-validity period reckoned from the extended closing date; where it does not, the Bidder shall furnish a suitably revalidated instrument with its offer.
- 3.2 This Corrigendum forms an integral part of the Enquiry and shall be read together with it and with Corrigenda Nos. 01 and 02. Bidders shall acknowledge receipt and submit a copy, signed and stamped, with the offer; an offer that does not acknowledge this Corrigendum shall be taken to have accepted it in full.
- 3.3 No further extension of the closing date is contemplated, having regard to the revised bid submission date under the RFP at Clause 1.2.
