#### 1. About MDL:

Mazagon Dock Shipbuilders Limited (MDL) is a leading Submarine and shipbuilding company in the country with a Navratna status. The company was taken over by the government of India and established as a public sector undertaking under the ministry of defence in 1960. Over the last six decades, MDL has delivered over 250 warships/submarine/ platforms to various customers in India and abroad, out of these 30 major warships/underwater platforms have been delivered to the Indian navy. The diversified platforms delivered to various customers range from destroyers, stealth frigates, Submarines, underwater platforms, missile boats, corvettes, offshore patrol platforms, multipurpose support platforms, offshore supply platforms, dredgers, tugs and cargo-cum-passenger platforms. The shipyard has also undertaken major refits of submarines and is presently undertaking medium refit cum life extension of SSK class submarines. The shipyard has capacity to build 11 submarines concurrently.

#### 2. Technical Requirement:

The XLAUV is an advanced Autonomous Underwater Platform designed for a wide range of strategic naval missions, combining cutting-edge technology with operational flexibility. XLAUV should be designed for smooth deployment, autonomous operations and precise mission execution, making it ideal for intelligence gathering, surveillance, mine-laying. The system should be engineered for high manoeuvrability, stealth and durability, ensuring success in complex and high-risk environments.

#### **Key Capabilities:**

- a. **Harbour Deployment & Return:** The XLAUV should be capable of deploying from an alongside pier within a harbour, carryout autonomous missions based on pre-set requirements and return safely without human intervention.
- b. **Autonomous Sea Transit:** The XLAUV should be capable of navigating autonomously from the harbour to open sea, adjusting its course based on the mission profile, ensuring efficient travel and optimal resource use.
- c. **Communication & Data Transmission:** The system maintains communication at regular intervals with a shore control station via satellite links, transmitting critical mission data and monitoring information for real-time decision making.

#### 3. Aim & Area of Collaboration:

MDL invites response from <u>Global Firms</u> meeting the requirements of this EoI for collaboration in Design, Development and Manufacturing of Extra Large Autonomous Underwater Vehicle (XLAUV).

The XLAUV is a next-generation autonomous underwater vehicle designed for high-endurance operations in restricted and shallow waters. The envisioned capabilities include:

- a. Intelligence, Surveillance, and Reconnaissance (ISR)
- b. Mine Warfare (MW)

#### 4. Purpose of EOI:

MDL seeks a global firm as a partner for the Design, Development & Manufacturing of Extra Large Autonomous Underwater Vehicle platform, leveraging the global firm's expertise in

advanced underwater technologies to complement MDL's capabilities and meet the customers' requirements. The key objectives of this collaboration include:

- a. **Partnership Formation:** MDL will act as the lead partner in the partnership, ensuring coordination and alignment with project objectives.
- b. **Bidding Strategy:** Collaborate on a robust bidding strategy for the upcoming Indian Navy's projects.
- c. **Preparation of Documentation:** 
  - i. Assistance to prepare Detailed Project Report (DPR) outlining the technical and commercial aspects of the project.
  - ii. Draft and submit a comprehensive response.
- d. **Commercial Bid Preparation:** Assistance to prepare and submit a competitive commercial bid.
- e. **Project Execution:** Upon receiving a Orders, develop an XLAUV platform that meets the customers' requirements and execute the project as per the agreed terms and conditions.

#### 6. Scope:

- a. MDL is seeking response from global firms, duly registered & incorporated under relevant law of the country, interested in collaboration with MDL for Design, Development and Manufacturing of Extra Large Autonomous Underwater Vehicle (XLAUV).
- b. The participating firm must have experience in area of Design/Development and Manufacturing or be in the process of manufacturing of Extra Large Autonomous Underwater Vehicle (XLAUV).
- c. The technology possessed by participating firm must be non-infringing while delivering the desired performance and it must be clear from third-party IP infringement claims.
- d. Interested companies meeting the Pre-Qualification Requirements (PQR) as given in **Annexure-1** and ready to associate with MDL as per broad scope/ expectations given above are invited to submit their offer in response to this EoI.
- e. Assistance to develop a Detailed Project Report (DPR) outlining the technical and commercial aspects of the project.
- f. Assistance to prepare a competitive commercial bid to IN.
- g. <u>Research and Development</u>: Collaborate on R&D activities for advanced XLAUV designs, leveraging global expertise and MDL's infrastructure.
- h. <u>Technology Co-Development:</u> Co-development includes concept design, preliminary design, critical design review, functional design, detailed design, facilitate transfer of critical technologies, ensuring compliance with intellectual property norms.
- i. <u>Manufacturing</u>: Partner with MDL in establishing production lines and ensuring highquality manufacturing standards
- j. <u>Prototyping and Testing</u>: Utilize MDL's testing facilities for developing and validating XLAUV prototypes.

- k. <u>Knowledge Sharing & Training</u>: Conduct training sessions and workshops for MDL personnel to ensure seamless technology adoption and operational readiness.

- a. The selected partner(s) will be granted exclusivity to collaborate with MDL on the design, development, and manufacturing of XLAUV for the duration of the project.
- b. During the exclusivity period, MDL and the selected partner(s) will not engage with other firms for the same scope of work without mutual agreement.
- c. The exclusivity agreement will be formalized as part of the definitive agreements, ensuring mutual commitment to the project objectives.

#### 8. Method of Selection:

#### a Evaluation Bids/offer:

- i. Offer received against the EOI will be opened, evaluated and recommended for empanelment by Screening/Evaluation Committee as soon as possible from the date of receipt and shall be subjective to approval by competent authority in MDL.
- ii. The applications will be shortlisted based on the parameters and criteria laid down in the document **Annexure-1**.
- iii. Pre-Bid Enquiry/ Limited tender will be sent to those shortlisted vendors.
- iv. Based on the criteria outlined in the Pre-Bid Enquiry/ Limited tender, a firm will be selected for the partnership.
- v. Definite agreement/ Consortium Agreement / placement of order will be done with the selected firm based on mutual agreed terms and conditions.
- vi. Any information contained in the Offer shall not, in any way, be construed as binding on the MDL, its agents, successors, or assigns, but shall be binding on the Applicant(s) if the empanelment is subsequently awarded to it.

#### b Clarifications:
