1. **Mazagon Dock Shipbuilders Limited** invites 'Expression of Interest (EOI)' from reputed Indian manufacturers for: -

- (a) Indigenous design, development, manufacturing, testing of Fire Retardant Single Door & certification by any IACS member.
- (b) Post successful trials of prototype the item has to be delivered to MDL, Mumbai to undertake trials on board Warships.

2. **Description of Work.** Design, Develop, Manufacture, Certification by IRS/IACS member & successful trials on board warships as per brief technical specification enclosed with this EOI at Enclosure-I.

3. **Pre-Qualification Criteria.** The interested manufacturer must fulfill the following minimum pre-qualification criteria and shall necessarily submit the relevant documents to support the claim.

(a) **Technical Criteria.**

(i) The bidder must have experience on design, manufacturing, testing & certifying similar items on Indian/international Naval vessels. (Proof to be submitted).

(ii) The bidder shall be an Indian Manufacturer having its own development & production facilities & with hands on experience of designing similar items in past & can undertake the design & development & production of Fire Retardant Single Door as per technical specification. The bidder has to submit documentary evidence (preliminary design/work) to establish the capability to undertake design, development & manufacturing of Fire Retardant Single Door.

(iii) The bidder has to submit proof of his capabilities to undertake Indigenous design, development & manufacture of Items in India. The bidder has to clearly specify in his offer that items offered will be: -

- (aa) Indigenously Designed, Developed, manufactured & tested in India.
- (ab) At least 60% of raw material used in manufacturing will be sourced in India..

(iv) The bidder has to submit the documentary evidence of above requirements, offers received without documentary evidence are liable for rejection.

(b) **Commercial:-**

- (i) The bidder shall be an Indian registered company having its registered office & manufacturing facilities in India.
 - (ii) The bidder shall be an original Indian equipment designer, developer & manufacturer of items.
 - (iii) The bidder shall provide the following details to determine their capabilities: -
 - (aa) Company Profile with date of registration.
 - (ab) Products Manufactured
 - (ac) Installed capacity at works.
 - (ad) Design & Manufacturing facilities available in house.
 - (ae) Previous Projects executed of similar nature.
 - (af) Certified balance sheet of previous three years.
 - (iv) Interested manufacturers should specifically indicate their interest in supplying Fire Retardant Single Door as per specification indicated at Enclosure-f.
 - (v) Manufacturer has to submit PAN/TAN No.
 - (vi) Traders/Agents/Dealers/foreign Bidders/consultant shall not be considered.
 - (vii) Bidders with import content more than 40% shall not be considered.
- (c) Based on submission of above information's & documents the firms will be qualified. Tenders will be issued to the qualified firm based on this EOI & qualification on Limited tender basis for prototype development. Post successful development of prototype the bidder will be qualified as a vendor for supply of this item to Indian Navy.
- (d) Timely submission of EOI is responsibility of the Bidders and no reasons / excuses in this regard will be entertained by MDL. MDL reserves the right to:
 - (i) Accept or reject EOIs submitted by the Bidders.
 - (ii) Cancel the process at any time without any liability and assigning any reason thereof.

- (b) **Submission of EOI.** EOI bids are to be submitted in sealed envelope prior to closing date & time. The bids are to be submitted in person or by registered post clearly indicating "BID for EOI for Fire Retardant Single Door" on top of envelope. Bids received after EOI closing date & time will be not considered for evaluation.
