However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. ### 3. Generic

OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of

any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

Note: The price "C" shall define the status of L1 during ranking. Cost to bidder "D" shall not

be indicated while quoting the price in the bid however, cost to bidder "D" shall be uploaded in a ".pdf" format under "Financial Documents Required" tab.

b) Total Project Cost (A) = Cost to MDL (C) + Cost to Bidder (D)

c) Bidder shall note that they have to mention the Cost to MDL (C) on GeM Portal and Cost to Bidder (D) on separate document in pdf format which shall be uploaded under "Financial Documents Required" tab.

d) Bidders shall note that in case the Cost to Bidder (D) is not uploaded under "Financial Documents Required" tab, their bid shall be considered as incomplete and ambiguous. Such bids shall be rejected by MDL. No further request/representation in this regard shall be entertained by MDL.

e) Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

f) The tax percentage (GST & CESS as applicable) quoted by the bidder shall be considered for **ITC based ranking**.

g) "The lowest quote will be calculated based on MDL cost towards the project. The MDL cost towards the project arrives = (Total cost of the project x MDL percentage share of the project). The lowest quoted bidder as per above method shall be awarded the contract."

h) If multiple bidders quote the same MDL cost share towards the project, then the bidder quoting the lowest total cost of the project shall be ranked L1 and such bidder shall be considered for award of the contract.

i) If still multiple bidders are have quoted the same lowest total cost of the project then the bidder quoting the highest local content shall be ranked L1 and such bidder shall be considered for award of the contract.

j) Offer of the bidder will be rejected if:

### 3) **EMD Exemption Clause:**
